Thank you for self-reporting the highlighted incidents in your email (below) to DOH and for already taking corrective action for all three (3). I have read GSD's account of these event and it's unfortunate they weren't caught by the Bud-Tenders when each purchase amount should have been crossed-checked against patient (available) allotments?

A NJMMP Monitoring Report has been completed citing violations of **N.J.A.C. 8:64-9.1(a)2 Procedures for safely growing and dispensing medicinal marijuana**. However, MMP will update these violations as being in compliance, since you've already taken corrective action and have disciplined the offending employees. ([REDACTED])
