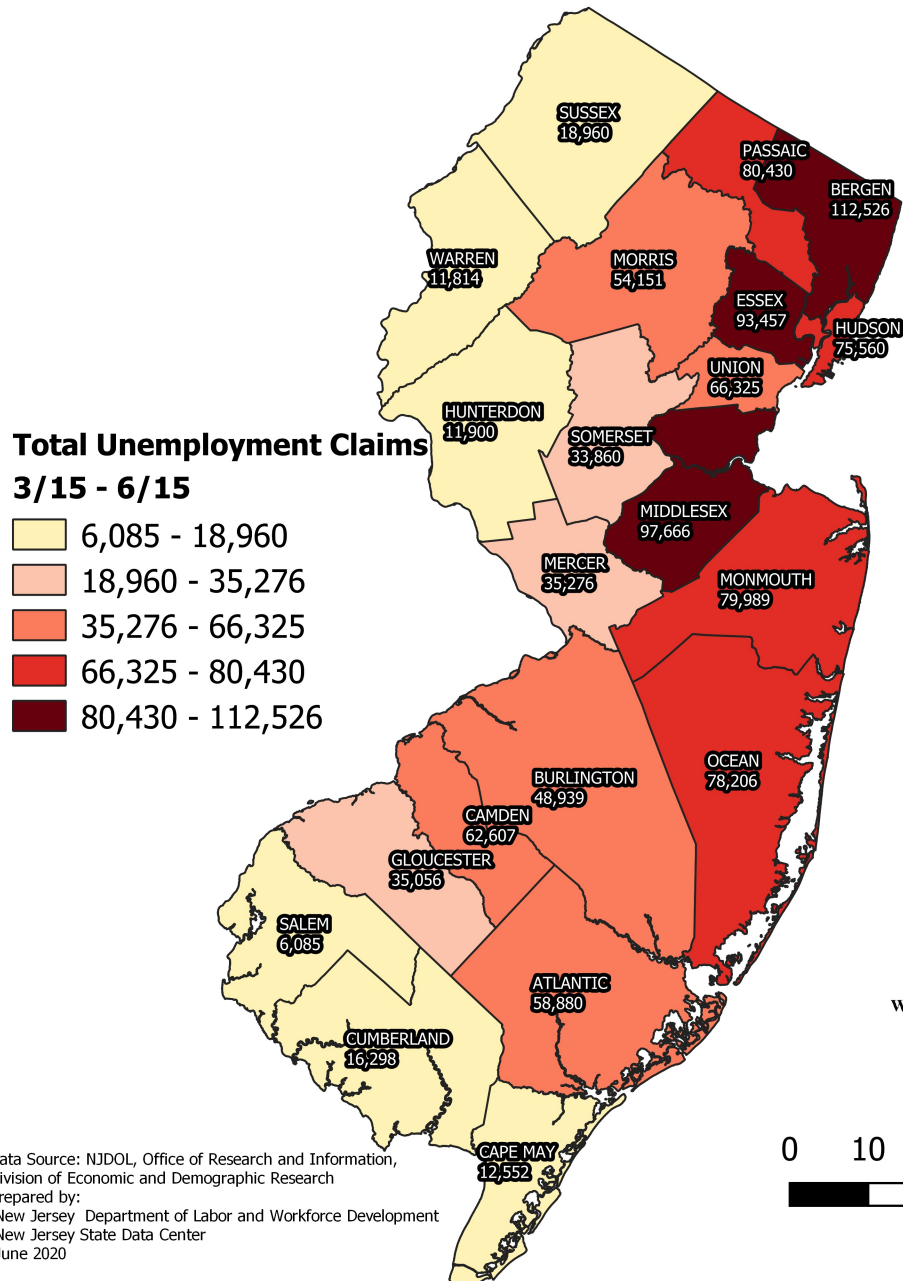

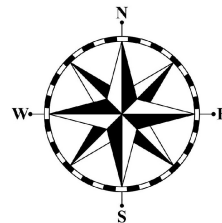
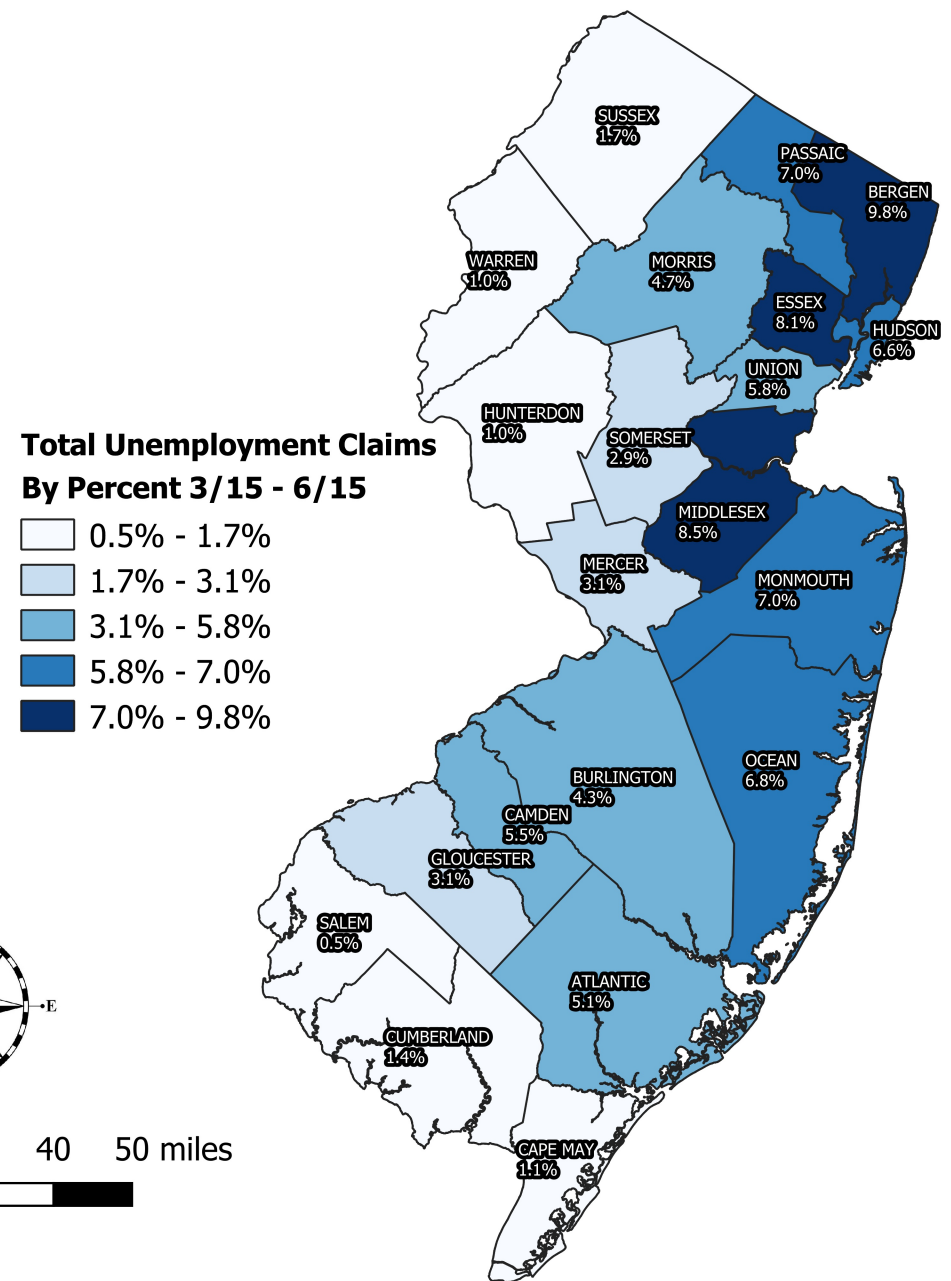

Total Claims by County



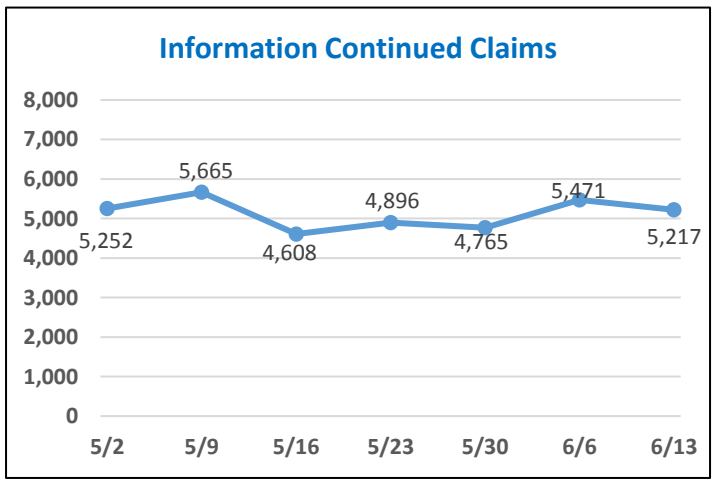
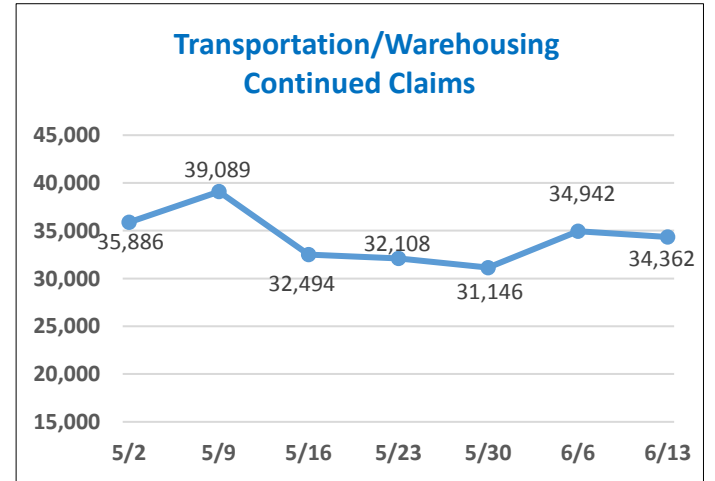
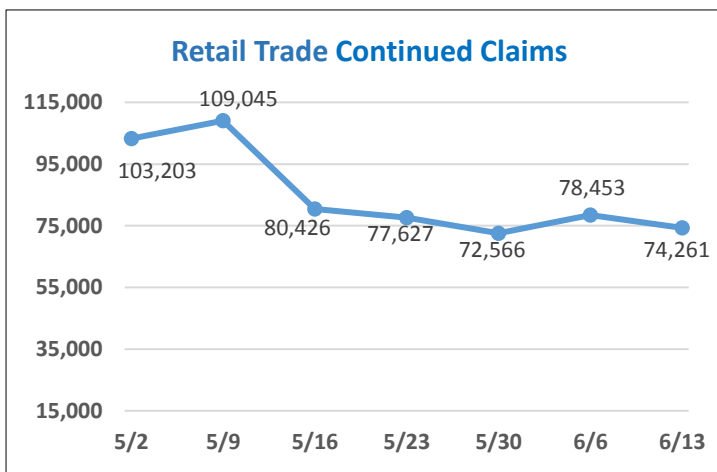
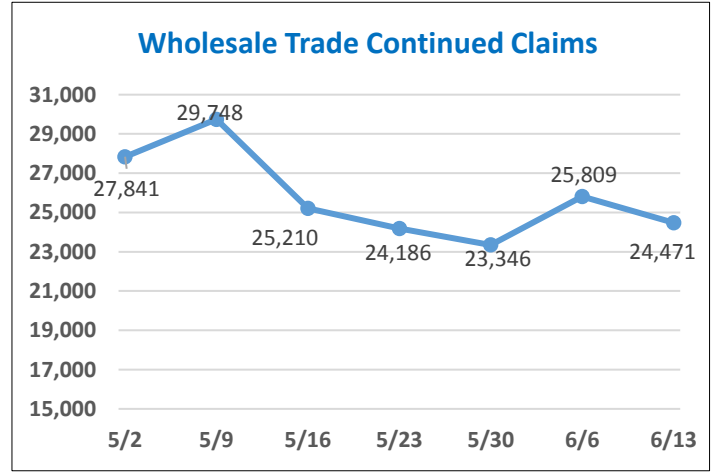
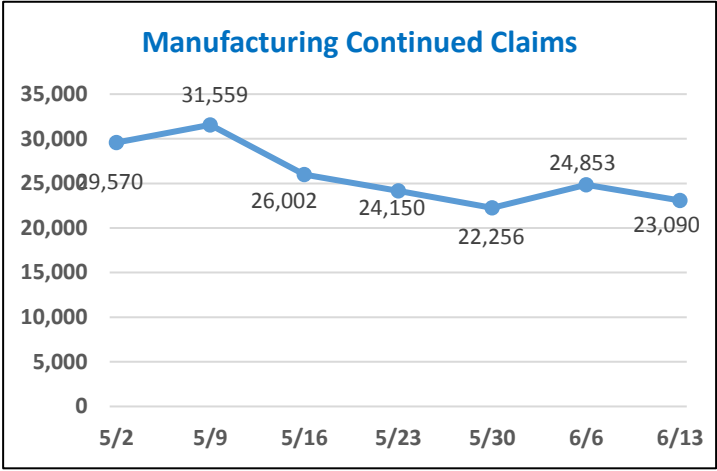
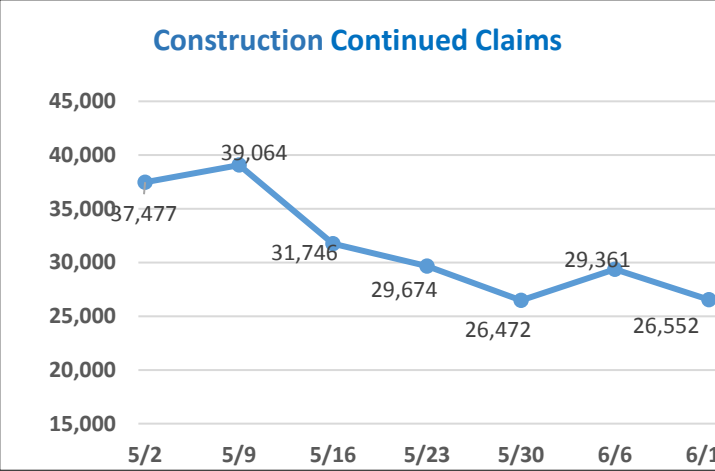
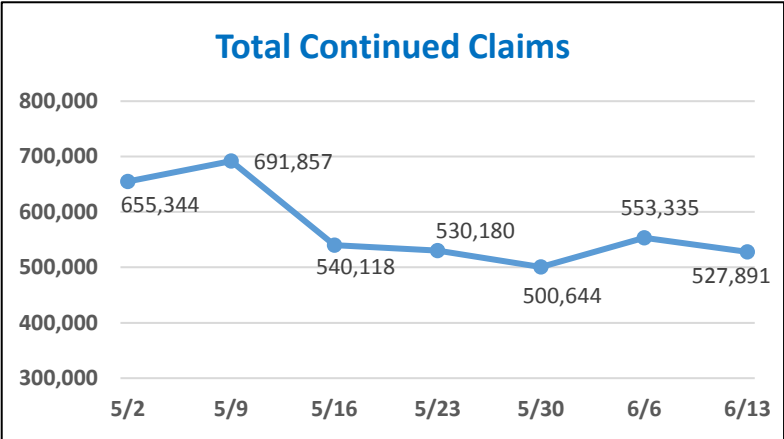

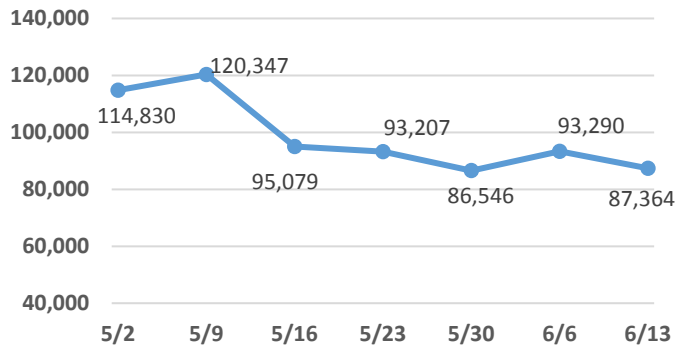
Professional & Business Services Continued Claims



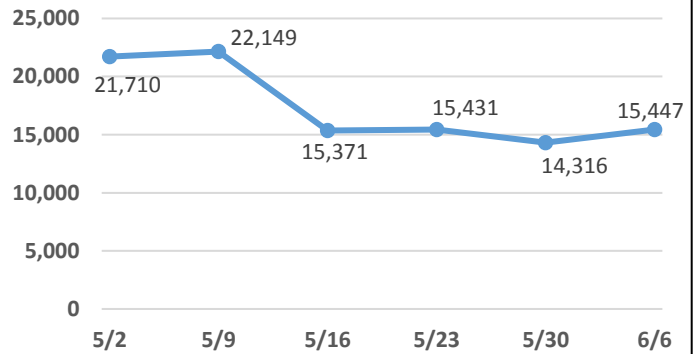
Financial Activities Continued Claims



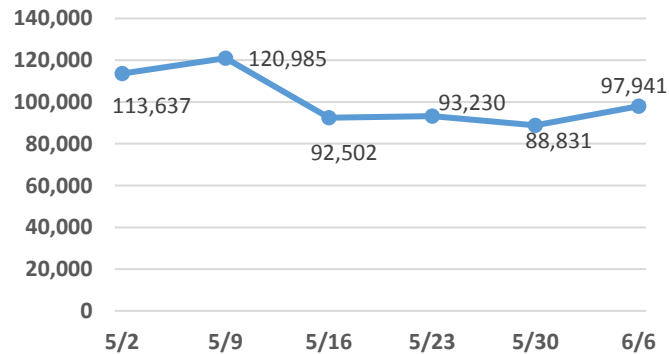

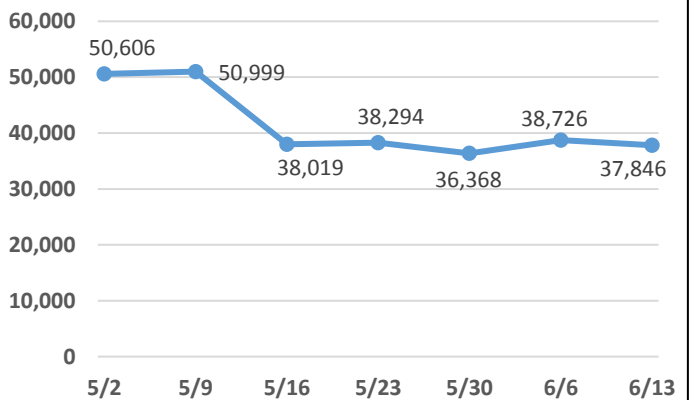
